Two canopied porches leading to the naya at the front of the villa. Naya is very spacious with lighting and central heating radiators, exposed timber beams and barrelled ceilings.

Living room s a nice size with stairs leading to the first floor, wood burning stove, hot and cold air conditioning unit, windows and doors off to:

Kitchen dining room which is a country style kitchen with a range of base and wall units, double sink and drainer, 5 ring gas hob (no extractor) space for an oven, space for a microwave, space for a fridge freezer, windows and a wood burner in the corner which is fairly normal for a country house.

Indoor swimming pool room with windows and a shower room with a walk in shower, W.C, bidet and wash basin.
