Entrance 1 is to the INDEPENDENT GUEST APARTMENT with a canopied porch, lighting and door leading to a hallway.

Hallway with double opening doors leading to the 2nd kitchen, 2 radiators, ceiling lighting, door to cloakroom, door to bedroom 4, store cupboard, stairs to the 2nd sitting room.

Guest cloak room with a w.c, wash basin, window, radiator and lighting.
