This property has 7 bedrooms and 3 bathrooms divided in two separate accommodations and also a separate guest suite. 2 private garages and an office above. Gorgeous mountain and castle views. Private pool, bbq area, terraces and sunny position. In need of work but with a lot of potential.

The approach to the property is via a cul de sac street shared with another house. Gated pedestrian access, staircase rising to the 1st floor.

The main level has a lovely tiled terrace with a barbecue area ideal for entertaining. From this terrace we have access to the main level apartment, guest suite and a staircase leading to the top floor apartment.

The downstairs apartment has a door leading to the glazed in naya with the most beautiful views of the mountains and the Castle of Forna. Another door leads us in to the open plan lounge dining room with a feature open fireplace, air conditioning unit, ceiling and wall lighting, two windows with pretty mountain views.
